As a one who during the Germen-Hitlers occupation in Poland 19392 1945 , rendered material and moral assistace to the Jewish residents of the Warsaw Ghetto, risking his own life, and as one whor rescued from oblivion important and priceless historical documents of the Warsaw Ghetto , know, as clandestine archive of Dr. Emanuel Ringieblum, which documents are valuable and there is no price for them, the market market value at the present are over-20% twenthy milions dollar, and handed them over to the Jewish Nation trought the Jewish Historical Institute-Museum, copies arealready in Israel-without an interest or reward, after 38 years hartship, after several Years of silence and hardship , and taking under consideration my present health condition and my present material problems-situation, I have decided, to appeal to the Jewish Nation trought the Jewish Religion and Social -Philantropies Organization, for material assistance in the form loan or reward on humanitarian grounds as well as any other type of renumeration. My request for material help motivating that axactly since March 1977. I am totally dissabled due to my fatalic condition state of helth-hearth attack this complicating the whole situation making hart to earn any money as completily dissabled, such a situation is very critical to live. The help from social security which is\$. 198,90, one hundred ninthe, eight dollars 90cents/, monthly is not enought to payrent, light, telephone, which exceed over \$.300.-monhly, and in such condition I am unable to pay for my doctors, hospital, operation bill and treatments and to keep the house it is just imposible to cope at such price hight cost of living, and I em have for paing two loans about over five thousands dollars, in the Industrial Commercial Federal Credit Union, 93I Manhattan Avenue, Brooklyn, N. York, II222, and my monhly payment of this loan-% is \$.200. Also my Hospital treatments in Parchway Hospital-Quens New York, after my acciden dent which I brok my right hand, this brok my hand has place in May 1978, when I was feel to baysment-celler, from the steps -stairs, and I not have any Insurance protection, and just few weeks ago when the doctor D.M. is took of the casked, proscribed me to the take a massage treatment due to bad blood circulation, I can not move with my all fingers of right hand and pain also, the whole arm is pain and can not more so in case like this I do need specianist doctors due to that my hand was broken in six place which had three metals niels. My social security not pay any hospitals and doctors bills. Social security will pay bills doctors, e.t.c., when totally disabled are two years period, and my totally dissabled of the period two years; be in March 1979/I am dissabled since March 1977, and now to the March 1979I be pay self all my doctors, e.c.T. How long will go like this it remain a question I have no bank savings account, since my coming to U.S.A., I never worked more then three day a week, becost my heath. Part of my health I lost by imprison mich by Gestapo-Germen-Hitlers-Police, seting in a baysment-celler prison in Warsaw during Hitlers occupation, when I was in prisoner over three months and I was beaten and starvation, I was tortured due to material and moral help-assistance to Jewish my Brothers, and sisters residents of the Warsaw and Wangrow Ghetto, / WangrowCity-about & 50 mile from Warsaw/, and from this time I not have many teths, I not have good memory/parhly loss of memory/, and I not have good health, and according to my health, my material situation-during about 38 years period, was and is now very bad. Now at this doctors care cost me about 7/S even thousands dollars/, and also my wife not have good health and was hospitalized in May 1975, about two weeks in New York University Hospital and due to opertion it cost abot 4/Four thousands doll and due to this situation I do no see any quick improvements in my present situation, but only a material help-assistance be given to me further treatment of

my broken hand and condition of my heart/end and my very bad circulation of blood, etc.,

I am sure being in the highest positionas you are, will make or organized a substantial fund for a such a pourpose like this, up now to now I never heard of a person or of a Organization, who could help for such a service which I have shouwn—Ith to all kind of race and faith of any Nation.

Before You and Jewish Organization founded for me some fund in the form international reward on humanitarian ground, as well as any other type of renumeration,

now, to best to form fund-and help me Quickly, I ask my addreesse, I proposal a cooperation in this matter with the Jewish Women Organization, and to best to form a fund it is best to transfer this matter to the Jewish Women Social-philantropics Organizations, which they very religious and social working with others Philantropics and Religious Organization with a good income of the

Jewish Head Organization.

Please transfer this matter for individual help-to the Jewish Women Organization, and I am convinced that the Jewish Women Organization will organized an impres or-them , cofie party, e.t. C., and very soon as posible will be sending to me a material help, from Jewish People, trought You, and trought Jewish Organization, and I shall acnowledge by an receipts with; notarized. By this ocasion I would to inform You that this is my secound appeal to the Jewish Religiob and Social-Philantopist, and Politics Jewish Organization. First time I was turned down to the many Jewish Religion and Social and Politycs Organization in 1969, when I had an acident, which accident turned to be of a very serious one, and very badly inju-ries of my leg and fracture ribs. Due to the fact that I was working in this time as an individual, self employed as a painter and I did not carry any accient Insurance protection, and I was about seven months totally unable to work, and in this very badly time for me and for me familly, my wife was working in Macy's shop in New York, for one dollar, and 25 cent on hour and salary for a week was netto about 32 dolars, my daughte ter was a student in Hunter Collegge in New York, and my monhly rent was with electricity, telephone, over two hundrets dollars . I would to explain to You that in this time, in 1969 the many registration

Page-3. letters in English was sending to the Jewish Religion, Politycs, Social Organization and as a matter of fact I not received any anwer from any of them. Only the Jewish World Congress in New York, and fifth/5/Rabbis from fifth Synagogues, send me a letter about this my appeal for help material, as following: World Jewish Congreess explaing in this letter: that as a Organization for politycs and social and religion fields, do not have any fund for- individual help. /photocopy of this letter is attached herwith/.

Only fifth/5/, Religion Organizations in New York, Fifth/5/, Rabbis from Fifth /5/, Synagogues, which send me a checks for \$-175/one hundred, seventhy fifth/, and the above help not even cover the cost of translation, not mentioned the cost of postage registered letters, and work involved of copies, e.t.c.

Total of contribution was \$175./one hundr & seventhy five/.-All names who rendered me material help in 1969 was reported to the rresident of Republic of Israel, and to Yad Washem U fiversity in Jeruzalem. If the addressess has turned in this very badly for me and for my familly time in 1969 to the Jewish Women Organization, I would have no trouble today/, I would have not work in such condition and dast and hemicalien, during the past IO years period, and I would have the today not breakly my right hand in many place, and my heart troble went be so bad, the heart condition and the blood circulation/according to Doctors opinions mayby I will totally dissab bled to end my life/.

Also if the Addressee would have shown good will would support and transfer this matter in 1969 to the International Jewish Religion, Social and Politycs Organization and I am sure a such would fund have been created in 1969, or in the later term. Also this matter should have been reported to the President Of Israel Republic, and to The Knesset in Jeruzalem, when I had about 10 years ago broken my ribs and very badly damagge my right leg and did not work about seven months, and I had no soucces to live, and I had to pay shool-Collegge for my daughter, and I pay many doctors bills.

But the Jugment belongs to the Hevenly Father and to History. And at present I found myself in a worst situation, and in more bad situation

material and health, than was about 10 years ago.

At the present I am completely dissabled very long period-since March 1977, due to my heart condition -complication, badly blood circulation, parthly loss of memory, and due to broken my right hand in few place and my stift hand finfers, are very bad I can not move/the contact broken parts of my nerves/, and I probably will be crripel the rest of my life and due to this fact I want to able to work and at present I have hope that people with the good will and with the social feealing, my Addressee will organized of for me a material help in my present very badly and critical time, and in future, will organized and create a special fund to help me.

If such a fund is not avialable, so they will suport me forwarded this matter to the Central Jewish Organization and also to The Government of Republic Israel with the appeal to finally help me material/create the special fund/, this concern the Archives of Dr. Emanuel Ringieblum, the Archives clandestine, as Archive of Warsaw Ghetto, with I save for Jewish Nation and for History, the

value over 20 milions dollars US.

I am sure I homestly deserved some how a award which enable me to live more piècefully, and hope that it this time You will not let me down without material help, as did other maybe Your ORGANIZATION , about 10 years ago.

At this occasion I would like to point out that I am under EVALUEV constant also M.D. doctor care due to my nervousness and heavy depresion which is very dangerous for my heart condition, and Your help quickly will help me my present time trouble, and I would be able to over come with my trouble. Also my marriage is after 35 Years is gravelly endanger and I am 60 Years of age o I am not propere at this time my stage of my health. After 37 Years of strugle for bare survival, a great part of it, under Hitler occupation, and the Stalinist regime. While in this country my health is been descriminatally affected by the nature of my work, dust, odors of paint, bensine, etc/.-I have been residing in New York since 1961, we arrived to USA, from Warsaw. Neither my wife received any compensation from West Germany for losses suffered during the secound world war, our private property valued at over milion dollars, was nationalized in Poland after the war bythe communist-Stalinist-Government. Therefore I want to mention that all the Eminent Person to whom I have turned about material help, will perform a good social deet, they will strenghten express my tanks and deep gratitude for Yours good hearth which rendered me a material help, in the form returnable loan or in the form unreturnable reward on the bassis humanitarian grounds, as well as any type of renumeration. I hope that You with another-Yours Friends , and with Jewish Women Organizations help mi quickly in this bad, hard time, and soon as posible will sending be to me a material help from Jewish People-Nation, trought You and trought Another Yours Friends, and Jewish Religion and Social Organizations, and one who help me will get a notrized receipts for such a donation is and they can be assured that in case such assistance is provided they will be given acknowlegment in the press or in the form they desire, according to Yours will and wish. Because to create a fund my take a very long time/months or even Years/, so the fact that my health and material sytuation is very bad, so I suggest that You take this matters in Your possibilities and I take think that You and the another the Eminent addresse is all possible-en and is in Your power of all Yours Members of Yours Organization as You are the President, so You could create a collection in form as loan, begining for om \$.20.00 and up and I will get as help, I will give a notary receipts, that I will return such an amount within two years according to their wish I will give to a Press that their name will e publisise, and I will give Your name to Yad Washem University in Jeruzalem. I think that each of Your Organization will be able to do so according to their trade or bussiness and se rvice they will came, I am sure You alone cannot do, but good will to pass it to Your associates, like women Organization who are ANX working for Your Organization, they are able , a will help as a philantropies. At this moment I do no see any other posibilities as such I am counting on You as a Jewish Leader of such Organizations I hope; , that You do not let me down, as I did my part and helped the Jewish Peoples many years ago, under the Hitler occupation of Europe, of word war two/.. Taking under consideration my present problms and my depresing stage I could fullin a worst at the Fifth Avenue, or Brodway, in New York, . I will be no suprice of I shall walk on my back, with a placarte with the recognition of University Yad Washem og Israel , as a Rightous. This decoration was given to me by official General Consul of Republic of Israel Mr. N. Eshkol, / photocopies are enclosed here with . I think that money are not everithing, but help will me in present time in my heatht problems/, I am not Young/I have very bad health condition, and after dead money are for nothing. I am sure being in the highest postion as You are, will make or organis zed a substancial fund for a pourpose like this. I never heard up now of an Organization, who could help for such a service, which I have , shown to all kind of race and faith of any Nation. I am looking forward to-hee hear from You in the gope that a result be in my favour.
