KNOW ALL MEN BY THESE PRESENTS :

that Mrs. Grete S i n a i nee Reiss of Shanghai, 171/18 Muirhead Road, a former Austrian subject, born on the 24th August 1915 at Vienna, today, on the 6th September, 1944, at Shanghai in the office of Mr. H. Ledien, Attorney-at-Law, 560 Dalny Road, in the presence of the following persons, whom she had designated to act as witnesses, namely

1. Mr. Heinz Cohn of 54/58 Chusan Road, Shanghai
2. Mr. Erich Lasus of 818/225 Tongshan Road, Shanghai
3. Mr. Hans Ledien of 560 Dalny Road, Shanghai

stated orally that she being of sound mind and disposing memory intended to make a "dictated will" in accordance with the provisions of Art. 1194 of the Chinese Civil Code. She stated orally :

" By judgement of the 1st Special District Court of Shanghai of the 28th February, 1942, my former marriage with Mr. Ernst Sinai was divorced. I do not want and do not deem it to be in the interest and to the advantage of our child, Carl Sinai, born on the 27th November, 1937, that my former husband, Mr. Ernst Sinai, should exercise any rights of custody, control, education, and guardianship of the child after my death, since my former husband has by deed of the 28th October, 1940, renounced any such rights, moreover, since, as I know, he is a drug addict, and is in no way apt and qualified to lead the education of the child. Therefore I hereby appoint

Mrs. Valerie Sinai nee Mayer of Shanghai, 171/18 Muirhead Road, born on the 16th April, 1885, at Zarošice, Czechoslovakia,

guardian of the aforesaid child for the time from my death on. Should this appointment not be legal and not sufficient to satisfy the provisions of Art. 1093 Ch. C.C., I nevertheless do hereby expressly declare that it is my desire to avoid that Mr. E. Sinai may exercise any such rights as described above towards the

child, and I hereby empower and authorize the said Mrs. Valerie Sinai nee Mayer to do all steps necessary and file all applications necessary with the authorities concerned in order to reach, that Mr. Ernst Sinai will be prohibited from exercising any rights of education, custody, control, and guardianship, as described above, with respect to the child, and that Mrs. Valerie Sinai nee Mayer is to be appointed guardian of the child for the time from my death on. This power and authorization, given Mrs. V. Sinai nee Mayer by this present, shall be valid and effective after my death. "

This oral statement was written down, read over, and explained by the witness Mr. H. Ledien. After the testator had given her approval, it was on this, the 6th day of September, 1944, in the City of Shanghai, signed by all the witnesses and the testator together as follows :
