

## Rockefeller Over The World

This is the United States of Standard Oil. That fact is plain. Standard Oil has ruled this country ever since William McKinley was elected President in 1896. That was the beginning of the flowering of private monopoly.

The head and front of all monopoly is Standard Oil. While ostensibly it was dissolved as a "trust" by decree of the highest court in 1912, actually, it has grown many times in wealth and power and its chief beneficiaries rule the world.

The Rockefeller family is the chief beneficiary of Standard Oil. Originally they owned about 25 per cent of all the stock in the 33 constituent "trust" corporations. Today they own or control thousands of corporations doing business in all parts of the world, and they control many other leading monopolies. The anti-trust law is a "dead letter," applied to them.

What is the result of all this private wealth accumulation? It is two world Wars and anarchy and revolution to follow. That is what happened to the republic of Rome when wealth-power became omnipotent in the hands of the Few and that is what is happening in the United States. The wealth-power of those who controlled private monopoly destroyed the republic of Rome and the wealth-power of those who control private monopoly is destroying the republic of the United States.

The Rockefellers are chiefly responsible for all that has taken place in this country. All other giants of private wealth are subordinate to them. They control politics, government, industry and finance. They control science and medicine. They control newspapers, magazines, movies and radio; and they control the people thru various subsidized agencies. That is why we have regimentation now and that is why we will have anarchy and revolution, unless the people wake up and prevent it.

The Rockefeller program was clearly outlined thirty years ago when their agent, the Reverend Frederick L. Gates, had the boldness and the indiscretion to put it in print. Gates was confidential agent of the late John D. Rockefeller. He was directing head of the Rockefeller General

Education Board, chartered in 1903. In 1916, he wrote in the publication issued by that Board known as "Occasional Paper No. 1," as follows:

"In our dreams we have limitless resources and the people yield themselves with perfect docility to our moulding hands. The present education conventions fade from our minds, and unhampered by tradition, we work our own good will upon a grateful and responsible rural folk. We shall not try to make these people or any of their children into philosophers or men of learning or of science. We have not to raise up from among them authors, editors, poets or men of letters. We shall not search for embryo great artists, painters, musicians, nor lawyers, doctors, preachers, politicians, statesmen of whom we now have ample supply. The task that we set before ourselves is very simple as well as a very beautiful one, to train these people as we find them to a perfectly ideal life just where they are. . . So we will organize our children into a little community and teach them to do in a perfect way the things their fathers and mothers are doing in an imperfect way, in the home, in the shop and on the farm."

That is the perfect caste system, the system that prevails in India, China and in other benighted countries—the system that prevents the children of the poor from rising above the economic and social level of their parents. That is the system that has led logically to regimentation. It took two world wars to produce it. It took a manipulated stock market inflation and collapse to help bring it about. It took a pliant President and a gang of evil minded advisers to put it over in twelve years. It took the corruption of the press, the acquaintance of public officials and legislators and the deception of the people, to accomplish it; and it has been accomplished.

Not only have Rockefeller agents succeeded in putting it over on a complacent and stupid people, but they succeeded in spite of all warnings and opposition by conscientious legislators and others. In discussing his bill to prohibit the giving of official status as dollar-a-year employes of the U. S. Bureau of Education to 157 employes of the Rockefeller General Education Board and the Carnegie Foundation, Senator Chamberlain of Oregon, said in the U. S. Senate on January 26, 1917:

"The Carnegie-Rockefeller influ-

ence is bad. In two generations they can change the minds of the people to make them conform to the cult of Rockefeller or the cult of Carnegie, rather than to the fundamental principles of American democracy."

Senator Kenyon of Iowa, made the direct accusation that "agents of Rockefeller had examined the curriculum of colleges and refused to endow them unless certain courses were stricken from the list." What were these courses? Evidently they were courses in economics that might have led to straight thinking. Since that time, college students have become enmeshed in all kinds of false economic philosophy.

Dr. W. J. Spillman, former chief of the Federal Farm Bureau under the Secretary of Agriculture, added his voice to the exposure of the Rockefeller educational program when he wrote in the New York Globe on March 28, 1919, as follows:

"Nine years ago I was approached by an agent of Mr. Rockefeller with the statement that his object in establishing the General Education Board was to gain control of the educational institutions of the country so that all men employed in them might be 'right'. I was then informed that the Board had been successful with smaller institutions but that the larger institutions had refused to accept the Rockefeller money with strings tied to it. My informant said that Mr. Rockefeller was going to add one hundred million dollars to the Foundation for the purpose of forcing his money into the big institutions."

All official warnings failed to awaken the people. The Rockefeller program has prevailed and we now have a generation of economically blind young men, and educators who are the willing or unwilling instruments of false economic teaching. We have a so-called philosophy of communism, socialism, single tax and of every other kind of ism to twist the brains and distort the minds of the people, but we have no straight thinking. There is no such thing as communism or socialism except in the realm of abstraction and single tax cannot apply to any established community.

One of the results of all this false economic teaching is the perfection of private monopoly on a world scale and a monetary system controlled by those who control private monopoly. We have food shortages and regimentation in all things and we are

heading toward world enslavement. We have hypocrisy, humbug and lying, we have an ignorant and deluded race. We have an inverted civilization. Could there be any more flagrant defiance of God. Can there be any greater betrayal of the people? In my booklet "Rockefeller or God—Who Will Rule?" published in 1938, I said:

"The greatest power that ever existed on this earth is in the hands of John D. Rockefeller. His is the power of life and death over the entire human race. He can cause war, maintain peace and starve or feed humanity. He can destroy civilization. His father attained this great power by substituting force and cunning for honor and fair dealing, and John D. must continue that course in order to maintain the power he inherited."

The late John D. Rockefeller started as a poor boy during the Civil War. His father taught him trickiness and deception. Soon the son outstripped the father in cunning. He acquired control of the oil business of the nation by trick and device and his family has held it and enlarged it since. In my booklet "Rockefeller or God—Who Will Rule?" I estimated the wealth of the Rockefeller family at five billion dollars (five thousand million) and their income at about \$250,000,000 a year. They had at one time about \$500,000,000 in their Foundations, the income of which were tax exempt under the law. The General Education Board has since been dissolved. Its purpose has apparently been accomplished.

In my booklet "Rockefeller or God—Who Will Rule?" I showed the extent of some of the Rockefeller-Standard Oil holdings in foreign countries. These holdings have since been greatly enlarged. Standard Oil securities have steadily increased in value and the assets of all the oil corporations in which the Rockefellers are interested, no doubt exceed ten billion dollars. Besides oil, the Rockefellers are financially interested in the largest industrial monopolies, local utility and railroad corporations, in the largest institutions and they own the largest share of securities of cities, states and nations.

The Rockefeller - Standard Oil interests in South America, the middle east, Europe and Asia, are almost as large as those in the United States. In fact, Standard Oil intends

to develop foreign fields almost exclusively, the current war having opened sources of supply and provided facilities that only partly existed before. The main source of new supply will be in that part of Asia in and around Arabia, known as the middle east. The United States recently paid Ibn Saud, Arabia's ruler, about twenty-five million dollars for oil and pipe line concessions which permitted the laying of a pipe line from the Persian Gulf to Haifa, in Palestine, where Standard Oil has a large refinery. The Standard Oil group also has a large refinery on Bahrein Island. They also have a pipe line from Iraq through Iran (Persia) to Haifa. During the San Francisco conference, which was run by Standard Oil agents, they entertained Ibn Saud's two sons and entertained the Arabian delegation there.

The grab for oil among the powers has been intense for many years and predictions have been made by leading statesmen, that war would result. Germany, Italy and Japan wanted independent and larger supplies. Mussolini went into Ethiopia in 1935, mainly for the oil of the Fafan valley there. Haile Selassie, the ruler, refused to surrender that part of his country when a division was proposed after the Italian invasion. Mussolini had built twelve tank steamers for Standard before his invasion of Ethiopia and Standard had built two refineries in Italy, Standard and Italy under Mussolini, were partners. Standard was also partners of France, China and Persia, besides being heavily interested in British and Dutch oil companies.

Standard was also tied up with the German Dye Trust, the largest industrial corporation in Germany, which was the second largest stockholder in Standard Oil of New Jersey and in some of its subsidiary corporations. Standard has refineries in Germany and in neighboring countries, particularly in Roumania, and Hitler built six tank steamers for Standard before 1939. Standard Oil officials always entertained Dye Trust officials in the United States before the war and the government contention in its suit with Standard over Dye Trust patents here is that Standard and the Dye Trust have a cartel arrangement to be renewed after the war. Germany was making oil from coal by a patented process, the use of which was forbidden in the United States. Germany and Russia were also making rubber from grain

alcohol, which process was not permitted in the United States.

Standard Oil is heavily interested in properties in territories controlled by Japan—in Formosa, Korea, Manchuria and North China — and they were represented there by the Mitsui, the Rockefellers of Japan. Standard Oil of California sold Japan millions of barrels of oil before Pearl Harbor, and other leading corporations and industrialists sold Japan millions of tons of scrap iron which were used against the Chinese, British, Dutch and Americans.

Standard Oil is heavily interested in Russia where it controls the Nobel Oil Works and they bought thousands of tons of magnesium from that country before and after the recognition of the Russian government by the United States government, in November, 1933. After the recognition, the tax on magnesium to Standard Oil was reduced ninety per cent by the Russian government. Standard Oil's publicity agent, the late Ivy Lee, Publicity urged the recognition of the Russian government, before Roosevelt became President.

Standard Oil and the British oil crowd virtually control the oil of the world. The Rockefellers are heavily interested in the Shell-Transport and British, American and Dutch interests control the Royal Dutch which controls the oil fields of the East Indies, which the Japanese coveted. Russia seeks oil expansion outside its own borders and France intends to cling to her empire and to a full share of all the oil in it; all of which means that the war for oil is still on.

In South America, Standard has vast oil holdings; so have the British. The Germans have been trying to get in. Standard's most important holdings there are in Columbia and Venezuela, and they own the largest refinery in the western hemisphere on the Dutch Island of Aruba, off the coast of Venezuela, in the Caribbean Sea. The Rockefellers own many large hotels in both those countries, which they constructed during the past few years. The Rockefeller Chase National Bank also represents a large interest in the Patino tin mines in Bolivia, acquired in recent years.

In the United States and Canada, the Rockefellers are on top. MacKenzie King, Prime Minister of Canada, was at one time on the payroll of the Rockefeller Foundation and the Imperial Oil Company which

operates throughout Canada, is one of Standard Oil's chief subsidiaries. The United States recently spent about \$150,000,000 in building a pipe line to the Canadian oil fields. The government also built a long pipe line along the eastern seaboard from Texas, known as the "big inch", and another pipe line further inland, both of which will probably be owned by Standard Oil and its affiliate corporations, when the war is over. Though millions of dollars were appropriated for the construction of shallow draught barges to carry oil on the inland waterways to relieve the shortage along the eastern seaboard before construction of the pipe line, none of the barges were ever put in use if they were built, and the alleged shortage continued during two winters to the discomfort and hardship of the people. Standard Oil will not suffer financial loss as a result of the war, because the United States government agreed to reimburse Standard for all losses due to the war.

The present war has brought vast additional wealth, to Rockefeller and Standard Oil. They now control synthetic rubber and chemicals besides hundreds of by-products of oil. The government appropriated several hundred million dollars to make rubber out of petroleum instead of out of grain alcohol which is a cheaper process, and it sent several hundred million dollars through the Kellogg Corporation, a corporate mystery, for products that only Standard Oil engineers and chemists know about.

The people of the United States are now the object of world hate and they are being dragged into a whirlpool of intrigue that they cannot comprehend. They know nothing about the meaning of Bretton Woods, Dumbarton Oaks or any other conference that has taken place at which some phase of our fate was decided, nor do they know anything about what is taking place at the San Francisco conference of nations. All they know is that there is such a conference at which so-called world problems are being discussed. The underlying facts and purposes of the conference are unknown to the people.

These underlying facts and purposes are well known to the Rockefellers and their agents who run the Frisco show. John Foster Dulles, counsel to the American delegation,

is a Rockefeller lawyer. He used to be head of the Federal Council of Churches financed by Rockefeller, which presumes to run the show. Raymond Fosdick, head of the Rockefeller Foundation, said in the New York Times a week before the show opened, that if the conference did not succeed in establishing and enforcing world peace, the world situation would be hopeless. He intimated that science was equipped to destroy the entire human race. World peace and a strong military power to enforce it, is necessary for the continued prosperity of Standard Oil in its operations outside the United States. The motto of Standard Oil has been "one thousand percent profit" and "everything for Standard."

The Rockefellers and their associates control the governments of cities, states and nations and they control most so-called reform and civic organizations besides political parties in the United States. They own the largest share of the bonds of most large cities and particularly of New York City, where they own about one billion dollars of wealth in real estate, public utilities, city bonds, etc., and they control all the leading public officials. No person, no matter how worthy, could be nominated or elected to high office in New York City or in any other large city in the United States, in the face of Rockefeller opposition. Newspapers would condemn him.

The Rockefellers want the copartative state in the United States, the same as it was in Italy under Mussolini. Their agents helped foster every kind of false economic doctrine under cover of which the corporative state has been established. The United States now owns and operates monopolies for domestic control, and it sanctions world monopolies such as Standard Oil, for world trade. In order to put this program over, it was necessary to control the White House and Congress, and Standard Oil and the Rockefellers have controlled those two agencies of government during the past twelve years. Frankfurter, Hopkins and others did their job in the White House and Baruch and others did it in Congress. Nelson Rockefeller, John D.'s oldest son, who is Assistant Secretary of State, recently announced that he intends to stay in politics and public life. Nelson is head of the newly created Foundation owned by the five Rockefeller brothers, which

owns most of the Rockefeller wealth.

There is a way out of our economic ills and a means of escaping the threat of world chaos, by simply following the law of God and nature. Moses adopted it in his day among the Hebrews. Lycurgus adopted it among the Spartans. Solon adopted it among the Athenians and Licinius adopted it among the Romans. All saved civilization in their day, when wealth became congested in the hands of the few. The Gracchus brothers tried to do it in the second century B. C. in Rome and were slaughtered with a large part of their following by the mobs owned by the senatorial monopolists. Jesus urged it and fought for it and was judicially murdered by the Roman governor at the behest and direction of the Sanhedrin in Jerusalem, consisting of the wealth-power of that province. Jesus advocated the law of limitation. There is a limit to everything in life, but no restriction on greed and He urged that greed be restricted by limiting what the individual could have.

I have been urging that program in virtually everything I have written for over thirty years, particularly in my book "Dynastic America and Those Who Own it," which I published in 1921, in which I showed who owned and controlled the wealth of the United States. That book is still the authority on great wealth in this country. In 1932, I published a book called "America Use Your Head" and I have been demanding such conduct of our people ever since. Either we use our heads and amend the constitution of the United States to provide for a limitation of excessive private fortunes, or we continue to ignore that remedy and suffer. Civilization has circled the globe and either we use our heads and correct our economic wrongs, or we will use our bellies when hunger talks, and destroy all wealth. A large part of it throughout the world is already destroyed. Roosevelt, Churchill, Hitler, Mussolini and Stalin served only as instruments of destruction.

If we can amend the constitution of the United States for superficial purposes such as prohibition and women suffrage, we certainly ought to be able to amend it for a fundamental purpose—to save the state of society. All we need is nine words in the Constitution — Congress shall have the power to limit private for-

tunes. Each generation could fix its own limit. Unless we do that this civilization is finished. World anarchy and world revolution will follow just as it followed the fall of the Roman Republic which was followed by five hundred years of social turmoil and spiritual darkness. Let us hope that the people will see the light and make Congress act.

The people can also make Congress stop the war. Congress alone has the power under the constitution. It can declare war and it can stop war. The President is commander in chief of the Army and Navy, subject to the control of Congress. Therefore concentrate on your Congressmen and Senators and make them act.

"The question is not whether monopoly is to continue. The sun sets every night on a greater majority against it. We are face to face with the practical issue: is it to go through ruin or reform? If we wait to be forced by events, we shall be astonished to find how much more radical they are than utopias. Louis XVI waited until 1793 and gave his head and all his investitures to the people who in 1789 asked only to sit at his feet and speak their mind. Unless we reform of our own free will, nature will reform us by force as nature does. Our evil causes have already gone too far in producing misery, plague, hatred, national enervation."

"Practical men are speculating today on the possibility that our civilization may some afternoon be washed away by the tick of a telegraph. All these co-operations can be scattered by a word of hate too many, and we left, with no one who knows how to make a plough or a match, a civilization cut off as by the Roman curse from food and fire. Less sensitive civilizations than ours have burst apart."

## INCREDIBLE! UNBELIEVABLE!

There has come to my desk a letter-head that makes the above words weak and ineffective, but there are no words strong enough for this crime.

"Rockefeller For President Club of Tennessee. Our goal; Elect Nelson Rockefeller President of U. S."

It is beyond belief that any American would vote for a Rockefeller for anything. The absolute ruthlessness of John D. in building his fortune, his disregard for human rights or legal rights placed him outside the pale of civilization. That he pursued this policy over the world is amply duplicated in Josephson's book: "**Rockefeller Internationalist.**"

The Ludlow, Colo. mining disaster in 1914 aroused the country against the Rockefellers, and from the testimony given at the time, it appeared that John D. Rockefeller, Jr., directing the fight against the strikers from 26, Broadway, sent the telegram which precipitated the Ludlow crime. 54 men, women and children were shot up and burned to death in the tent-colony of the striking miners.

John D. Rockefeller, Jr. swore on the witness stand before Congress that his father would spend every dollar he had in the mines of Colo. (\$20,000,000) to defeat the miners in their effort, through their union, to obtain a living wage and escape extortion on the part of the Rockefeller bosses. Rockefeller employees were shot down in Bayonne, N. J., after they struck for a living wage. Though Standard Oil was making from 100 to 1,000 percent profit, it was paying its laborers less than other oil companies and not enough to live on decently. In Roosevelt, N. J. strikers were shot down by hired gunmen as in Colo. The families of workmen were obliged to live on \$1.60 a day. The Congressional Committee concluded "that he (John D., Jr. Wasn't he a famous Sunday School teacher?) would rather spend money for guns, detectives and mine guards and starve the strikers into submission."

"My Last Fifty Years" by Henry H. Klein (if you can find it) will give you on the spot history of this criminal gang. Klein says, on page 79:

"From the time I read Ida Tarbell's book, "History of the Standard Oil Company", published in 1904 by McClure, and Henry Demerest Lloyd's book, "Wealth Against Commonwealth", published in 1894, I realized the menace of Rockefeller and the manner in which his wealth was being acquired."

The present day view is in Emanuel Josephson's, Rockefeller "Internationalist". In Josephson's "Your Life is Their Toy", is told the worst crime of the Rockefellers, the corruption of our education.

There were men in our country then who had the wisdom to protest. In 1913 Senator John W. Works declared in a speech in the Senate in

opposition to the attempt to incorporate the Rockefeller Foundation, "We do not want our children to be taught the ways nor the methods of John D. Rockefeller or his kind, nor to be generous with ill-gotten gains; nor to touch, handle or profit by gold that **should blister the fingers of the man who has accumulated it by extortion, oppression and worse.**"

There is no longer, blacker page in our history. We shall see if Americans are so lost to all honor and decency as to vote for a Rockefeller.

The super government is being established piecemeal. All preliminary steps have been taken. Its establishment will be complete when the so-called Security Council of the U.N.O. controls the atomic bomb and the army, navy and air forces of the United States, Great Britain and Russia. The Standard Oil—Sanhedrin group will rule the Security Council. Their scientists developed the atomic bomb and they rule the army, navy, and air force in the United States.

The United States of America is now the United States of the U.N.O. and will remain so as long as the super government exists. Those who fought and died for freedom in America, have fought and died in vain. The Sanhedrin and the Money Gang tried to take it away from them through the League of Nations and failed. They will succeed through the U.N.O.

THE PEOPLE MUST RISE —

LINCOLN WARNED US NOT TO TRUST LEADERS

Feb. 11, 1861

When the people rise enmass in behalf of the Union and the liberties of this country, truly may it be said, "The gates of hell cannot prevail against them." In all trying positions in which I shall be placed, my reliance will be upon you and the people of the United States; and I wish you to remember, now and forever, that it is your business, and not mine; that if the union of these states and the liberties of this people shall be lost, it is but little to any one man of fifty-two years of age, but a great deal to the thirty millions of people who inhabit these United States, and to their posterity in all coming time. It is your business to rise up and preserve the Union and liberty for yourselves, and not for me. I appeal to you again to constantly bear in mind that not with politicians, not with Presidents, not with office-seekers, but with you, is the question: Shall the Union and shall the liberties of this country be preserved to the latest generations.
