# Holocaust deniers sued by California survivor

Eleven years ago, Los Angeles resident Mel Mermelstein had his first runin with some of the United States' more sophisticated Holocaust-deniers.

In 1980, he took up a \$50,000 offer by the Institute for Historical Review (IHR) to prove that Jews were gassed at Auschwitz. When the institute refused to pay, Mermelstein. whose mother and two sisters were murdered at the death camp, sued the IHR, eventually obtaining a \$90,000 consent judgment as well as an apology.

On August 9, the Holocaust survivor will again be in court facing the IHR and three other parties. Mermelstein is bringing four grounds of suit against the Legion for the Survival of Liberty, which does business as the IHR, the Liberty Lobby and Willis Carto, founder of the organizations.

He is suing for defamation, malicious prosecu-tion, intentional attempt to inflict emotional distress and conspiring to inflict emotional distress.

Mermelstein is asking for millions of dollars in damages, his lawyer, Jeffrey Mausner, told The CIN.

"We will show [the groups] are anti-Semitic and racist," he said.

Mausner said the allegation of defamation arises out of a 1985 IHR newsletter in which Mermelstein was called a "demonstrable fraud, false tale spinner and a vainglorious prevaricator.'

The other legal grounds arise in response to a suit filed by the institute against Mermelstein that was quickly dismissed. "We're going to present witnesses and evidence to centre on whether the law suit brought against (Mermelstein). . . was frivolous and brought with malicious intent," Mausner said. The IHR sued Marmel-


stein following a a 1985 New York radio interview in which the organization claimed that Mermelstein libelled them on the air.

Following withdrawal of the suit, Marmelstein sued for malicious prosecution, alleging the IHR suit was groundless.


Mausner, who worked for the Nazi-hunting Office of Special Investigations from 1979 to 1985, said that in a procedure in advance of the trial, Judge Stephen O'Neill of the Los Angeles Superior Court took judicial notice of the fact that Jews were gassed to death in Auschwitz in 1944.

Mausner said that was relevant to the defamation allegation, since the IHR and the other defendants might have alleged that Mermelstein was lying about events of the Holocaust.

The jury trial is expected to last about three weeks.
