

Letter, sent from the Dachau concentration camp to the Reichssicherheitshauptamt (Main Security Office) in Berlin on November 13, 1941

Secret

The commandant's office at the Dachau concentration camp informs the Main Security Office of the execution of 135 Russian prisoners of war on November 12, 1941. Below is a list in the document listing the shot Russian soldiers according to their camp numbers. There are 23 prisoners from Stalag (POW camp) IV/B, 5 from Stalag VII/B, and 107 from Stalag Frt. 304

The Russian POW Igantziuk Iwan (Stalag (POW camp) VII/A) suffers from a contagious disease and can not be transported from the sickbay in Freising.

Then there seems to be another letter on the same page to the Gestapo in Munich, also on November 13, 1941.

We send you this letter for your information and also the attached Bekleidungsachweise (proof of clothing)

The letter also has a seal that says it was received by the Gestapo on November 15, 1941.

Letter, sent from Stalag (POW camp) VII A in Moosburg to the Gestapo in Munich on January 28, 1942

Most part of the first page is a table that showing the correlation between the Gestapo orders for transfer and actual transfer to the Dachau concentration camp. The prisoner numbers are matched.

On the left side of the table is an overview of the demanded prisoners of war and the corresponding dates. Altogether the Gestapo in Munich demanded 271 and the Gestapo in Regensburg 34 Russian prisoners of war (total: 305)

On the right side of the table there is a list of transports to Dachau concentration camp. Altogether, 301 Russian prisoners of war were transported to Dachau. Two POWs were missing in the transport on October 21, 1941 and two more on November 12, 1941.

Under the table the reasons for that are given at x) and xx):

Michail Dotschuk wasn't transported because of contagious disease

Mogutow Wasilij wasn't in the transport on October 21 because he has already been transported on October 14, 1941.

Igantziuk Iwan wasn't transported because of contagious illness.

Stupenko Iwan wasn't transported because of an assignment by Commissar Schermer.

Before the prisoners of war were transported to Dachau, the Dachau concentration camp and the Secret State Police in Munich were informed.

The leader of the transport was given an envelope to personally hand it over to the commander of Dachau concentration camp.

The letter has a seal that says it was received by the Gestapo on January 29, 1942.

Letter, sent from Stalag (POW camp) VII A in Moosburg to the Secret State Police in Weimar and to the concentration camp Buchenwald (near Weimar) on March 19, 1942

The message also went to the Gestapo in Munich and Regensburg

Like already advised on the phone on March 19, 1942, 422 Russian POWs are ready for being transported from Stalag (POW camp) VII A (in Moosburg) to Buchenwald concentration camp on March 20, 1942, 10 PM.

Estimated day of transport: March 27, 1942.

The letter has a seal that says it was received by the Gestapo in Munich on March 21, 1942.

Subject: the execution of Russian prisoners of war

On April 27, 1942 at 10:40 AM

Urgent

I ordered the transport of 13 Russian POWs to be executed in the Dachau concentration camp on April 29, 1942. The transport will arrive on April 29, 1942 at around 4 PM at the central train station in Munich. The prisoners are from a quarantine camp, so they can't be put into a police arrest and should be transported to the Dachau after arriving in Munich.

The telegram has a seal that says it was received by the Gestapo in Munich on April 27, 1942.

Subject: the execution of Russian prisoners of war

On April 27, 1942 at 1:57 PM

The yesterday announced transport cannot be exercised because of the urgent official reasons. It has to be rescheduled some days later. I will let you know ahead of time and ask you to provide the auto transport at that time.

The telegram has a seal that says it was received by the Gestapo in Munich on April 28, 1942.

On April 30, 1942 at 2:08 PM

He refers to the telegrams sent before and advises them that the 13 Russian prisoners of war will arrive in Munich on May 1, 1942 at 4:02 PM. He asks to provide an auto to transport the POWs to Dachau.

The telegram has a seal that says it was received by the Gestapo in Munich on April 30, 1942.
